Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs.12.00 crore bank facilities Dr. M Hope Hospital Private Limited (HHPL). This rating is now an indicative rating and is based on best available information.
