**Rating Rationale**

Acuite has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) and the short-term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 22.32 crore bank facilities of VRIJESH NATURAL FIBRE AND FABRICS INDIA PRIVATE LIMITED on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Incorporated in 1984, Vrijesh Natural Fibre And Fabrics India Private Limited is a Mumbai-based company promoted by Mr. C. L. Agarwal and family. The company is engaged in the manufacture of linen fabrics, scarves and home textile products at Vapi, Gujarat. The installed capacity stands at 250 MTPA.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
