Acuite has reviewed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 12.00 crore bank facilities of Kadaba Press Metal and Plastic Moulds Private Limited (KPM). This rating is now an indicative rating and is based on best available information.

KPM founded by Mr. K G Rangaraj and Mrs. RanjiniRangaraj have entered into a lease agreement with Velankani Electronics Private Limited (VEPL) with effect from November, 2015. KPM proposes to construct an industrial shed and lease out the same exclusively to Velankani Electronics Private Limited for a minimum period of 10 years. VEPL plans to set-up an electronic manufacturing facility in the mentioned premises and on completion of the 10 years lock-in period, will have an option to renew the lease five years from then, on manually decide terms.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
