Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE Do)n Rs. 8.82 crore bank facilities of V & V Pharma Industries (VV). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
