Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus)on the Rs.8.50 crore bank facilities of Satyam Wovensack Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2010, Satyam Wovensack Private Limited is Gujarat-based Company promoted by Mr. Vikas Garg. The company is engaged in manufacturing of woven fabrics which are used in various textile, packaging and agricultural industry. The company has its manufacturing unit located at Navapara, Gujarat with an installed capacity of 2, 25,000 meters per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
