Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+ (read as ACUITE B Plus)**' and the short-term rating of '**ACUITE A4 (read as ACUITE A four)**' on the Rs.11.20 crore bank facilities of Zenith Engineering Corporation (ZEN). The rating continues to be flagged as "Issuer Not Co-operating" and is based on best available information.

About the Company

Vadodara based Zenith Engineering Corporation (ZEC) is a closely held partnership firm led by Mr. Manish Gyani, Mr. Rakesh Zaveri and Mr. Vikas Chavda and family. The firm, established in 2005 is engaged in the manufacturing of LT electrical control panels and bus ducts at Vasai Road near Mumbai. Production commenced in 2006.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
