Acuité has downgraded the long-term rating to '**ACUITE BB+** (read as **ACUITE double B plus**) from '**ACUITE BBB-** (read as **ACUITE triple B minus**) and also downgraded the short-term rating to '**ACUITE A4+** (read as **ACUITE A four plus**) from '**ACUITE A3+** (read as **ACUITE three plus**) on the Rs.13.00 crore bank facilities of Venus Stampings Private Limited. This rating continues to be flagged as "Issuer Non-Cooperating" and is downgraded on account of information risk.

VSPL was incorporated in 1985 by Mr. D. N. Kathuria. The company is engaged in the manufacture of laminations for magneto, alternators, armature, and stator motors that find application in automobiles and electrical generators. The management has experience of over three decades in the company's line of business.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
