Rating Rationale

Acuite has reaffirmed the long-term rating of **'ACUITE D' (read as ACUITE D)** on the Rs. 12.00 crore bank facilities of Shree Ram Ashiana Private Limited (SRPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shree Ram Ashiana Private Limited (SRPL), the Agra-based real estate company incorporated in 2008 by Mr. Manish Jain and Mr. Sumit Jain in developing a residential project 'Paras-II' at Agra, Uttar Pradesh. The company had already received customer advances of Rs.8.9 crore till December, 2016. For FY2015-16, the net worth stood at Rs.8.20 crore as on March 31, 2016, as against Rs.7.70 crore in the previous year.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
