Acuite has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 10.00 crore bank facilities of Sai Sanskrithi Educational Society. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Himachal Pradesh based SSES was established in the year 2008 by Mr. Vijay Bhaskar Reddy as a founding member. At present, management of subject is vested in the hands of Mr. V Barla. SSES provides technical qualification in the field of management and engineering. At present the society runs post-graduation courses in management and graduation courses in engineering.

Non-cooperation by the issuer/borrower:
