Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 10.00 crore bank facilities of Sai Sanskrithi Educational Society. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Himachal Pradesh based SSES was established in the year 2008 by Mr. Vijay Bhaskar Reddy as a founding member. At present, management of subject is vested in the hands of Mr. V Barla. SSES provides technical qualification in the field of management and engineering. At present the society runs post-graduation courses in management and graduation courses in engineering.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
