Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs. 10.00 crore bank facilities of Sai Sanskrithi Educational Society. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Himachal Pradesh based Sai Sanskrithi Educational Society was established in the year 2008 by Mr. Vijay Bhaskar Reddy as a founding member. At present, management of subject is vested in the hands of Mr. V Barla. Sai Sanskrithi Educational Society provides technical qualification in the field of management and engineering. At present the society runs post-graduation courses in management and graduation courses in engineering.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
