Acuite has reviewed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.8.98 crore bank facilities of Sushila Agrovet Private Limited (SAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SAPL, incorporated in 2007, is a Mumbai-based company engaged in the breeding of broiler birds of Vencobb 400Y breed and selling of hatching eggs. The company was promoted by Mr. Sudhanshu S. Naik, Dr. Subodh S. Naik, Dr. B. D. Patil and Mr. G. P. Puro. The company procures day-old parent chicks from Venkateshwara Hatcheries, grows them and sells the fertile broiler hatching eggs. The poultry farms are located at Satara and Alibag.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
