Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 8.25 crore bank facilities of Sri Jayamalar Spinning Mills Private Limited (SJS MPL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
