**Rating Rationale**

Acuite has reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 11.35 crore bank facilities of SS Multi Services (SSMS). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

SS Multi Services is a Navi- Mumbai based company established in the year 1990 by Mr. Surendra Kumar Shukla. The firm is engaged in the business of providing toll fee collection services vehicle parking management services and undertakes civil work contracts.

**Unsupported Rating**

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
