Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.9.72 crore bank facilities of Shreyans Packaging (SP). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

Maharashtra-based, SP is a proprietorship concern established in 2012 by Mr. Rajesh Kocher. The firm is engaged in manufacturing of corrugated boxes. Its manufacturing unit is located at Hinganghat with an installed capacity of 1800 tons per month.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
