Rating Rationale

Acuite has downgraded the long-term rating to **'ACUITE B' (read as ACUITE B)** from **'ACUITE B+' (read as ACUITE B plus)** and reaffirmed the short-term rating of **'ACUITE A4' (read as ACUITE A four)** on the Rs.21.76 crore bank facilities of Mittal Ceramics on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Uttar Pradesh-based, Mittal Ceramics is engaged in the manufacturing of glass bottles. The company was incorporated in 2010 and the manufacturing capacity of the firm stands at ~90 tonnes per day. The firm procures raw materials such as borax, feldspar, sodium nitrate and potassium among others from companies including Gail Gas Limited, Nirma Limited and K. Kumar & Co-located at Ahmedabad, Firozabad, Kolkata. The company is currently managed by Mr. Raj Kumar Mittal.

Non-cooperation by the issuer/borrower:
