#### **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE C' (read as ACUITE C) on the Rs. 9.00 Crore bank facilities of Chintpurni School. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

#### About the Company

Chintpurni School was registered in 2006 and is headed by Mr. Sunil Joshi, Mr. Adarsh Mohan and Mr. Vikram Joshi. The society runs "The Heritage School," a boarding school located at Pathankot, Punjab. The school offers classes from Kindergarten to 12th standard with total student's strength of 875 students.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
