Rating Rationale

Acuité has downgraded the long term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 20.00 crore bank facilities of Rohil Foods Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Rohil Foods Private Limited is engaged in the milling of basmati and non-basmati rice, since 2009. The company operates a rice mill at Kaithal in Haryana with an installed capacity of 12 metric tonnes per annum (MTPA). Besides, it is also engaged in the trading of cottonseed oil, cotton cake, bran, husk and other agro commodities, which contribute to less than 5 per cent of their revenues. Rohil Foods Private Limited is promoted by Mr. Vinod Khurania, Mr. Praveen Khurania and Ms. Sonia Khurania.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
