Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.50 crore bank facilities of Narsingh Hospital & Heart Institute Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Narsingh Hospital and Heart Institute Private Limited (NHHIPL), is based in Haryana was incorporated in 2006 as a private limited company was promoted by Dr.Ramesh Batra. The company runs a 100 bed multi-speciality hospital at Murthal Road, Sonipath and offers healthcare services in the areas of neurology, cardiology, orthopaedics among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
