Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs.132.64 crore bank facilities of Baliraja Sakhar Karkhana Limited (BSKL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Pune based Baliraja Sakhar Karkhana Limited (BSKL) was incorporated in the year 2001, it is promoted by Mr. Shivaji Bhagwanrao Jadhav and family. BSKL is engaged in the manufacturing of sugar and its byproducts. The company also undertakes electricity generation.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
