Acuite has reviewed long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as '**ACUITE A four**') on the Rs. 20.00 crore bank facilities of Sintech Precision Products Limited (SPPL). This rating is now an indicative rating and is based on best available information.

SPPL, established in 1986, is a Ghaziabad-based closely held public limited company promoted by Mr. N.C. Dhingra. The company is engaged in manufacturing of pumps used in mining, power, cement and sugar industries. The day-to-day operations are managed by the Directors, Mr. N.C. Dhingra, Mr. Sachit Dhingra and Mr. Sahil Dhingra.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
