Acuité has reviewed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 7.25 crore bank facilities of Prerona Infrastructure Private Limited (PIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

PIPL incorporated in 2010, is a Kolkata-based company promoted by Mr. Mriganka Hazarika. The company has set up a three-star hotel under the name 'Gateway' in Guwahati with 49 rooms, banquets and restaurant facilities. The hotel also has a gym, spa, bar and offers 24 hour Wi-Fi facility.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
