Rating Rationale

Acuite has long-term rating of 'Acuite BB-' (read as Acuite BB minus) on the Rs. 7.40 crore bank facilities of Bright Star Syntex Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

About the Rated Entity:

Bright Star Syntex Private Limited (BSSPL) was incorporated in 2002 as a private limited company. The company is engaged in the spinning, weaving and finishing of textiles (Jacquard woven fabrics/curtain). BSSPL was promoted by Mr. Bijay Agrawal and Ms. Saroj Agrawal. The manufacturing unit is located at Tarapur, Thane.

For FY2014-15, BSSPL reported profit after tax (PAT) of Rs.0.37 cr on total income of Rs.18.33 cr as against PAT of Rs.0.38 cr on total income of Rs.16.23 cr for FY2013-14.
