#### Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (**read as ACUITE B Plus**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) the Rs.25.60 crore bank facilities of Air Control and Chemical Engineering Company Limited (ACCECL). This rating is now an indicative rating and is based on best available information.

#### About the Company

ACCECL, incorporated in 1961, is a Gujarat-based company owned and managed by Mr. B. R. Daga and Mr. Vishal Daga. The company, apart from providing turnkey solutions in refrigeration and airconditioning, is also engaged in the manufacturing of compressors and fans.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
