Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus)from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.36 Cr bank facilities of Gnanabella Logistics (GL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Gnanabella Logistics (GL) established in 2012, is a Trichy-based partnership firm that provides transportation services in Tamil Nadu, Kerala and Andhra Pradesh. The firm is promoted by Mr. Gnanaraj Ranson Thomas Arokiaraj, Mrs. Vincent Joy Josephine and Mrs. James Isabella.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
