Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.31.57 Crore bank facilities of Zazsons Exports Private Limited. This rating is now an indicative rating and is based on best available information.

Kanpur-based, Zazsons Exports Private Limited (ZEPL) established in 1986 is engaged in the manufacture and export of leather products (made of goat and sheep skin) to Europe. The company is led by Mr. Tahir Husain.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
