Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 7.45 Crore bank facilities of Realtech Developments and Infrastructure India Private Limited (RDIIPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Delhi-based, Realtech Developments and Infrastructure India Private Limited (RDIPL) was incorporated in 2012 by Mr. Hitesh Yadav and Mr. Atul Yadav. RDIPL is engaged in developing residential and commercial complexes. The company has land bank of 25 acres. Currently, RDIPL is developing a residential project named 'The Luxurium' having saleable area of 332160 square feet. The project was launched in 2015 consisting of 207 units and located in Gurgaon (Delhi).
