Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.12.00 crore bank facilities of Mahalaxmi Saw Mill. This rating is now an indicative rating and is based on best available information.

Mahalaxmi Saw Mill (MSM) was established in 1997. MSM is engaged in the business of import and trading of timber. The firm majorly imports timber from countries such as Malaysia, Columbia and Latin American countries.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
