SMERA has reviewed long-term rating of '**SMERA B-**' (read as **SMERA B minus**) and short term rating of '**SMERA A4**' (read as '**SMERA A four**') on the Rs. 8.85 crore bank facilities of Bathsha Marine Exports Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

The Kerala-based Bathsha Marine was established in 1997 by Mr. Akbar Bathsha Mrs. Sunitha Bathsha and Mr. Yazar Bathsha Directors. The company is engaged in the processing of marine products and commercial production is expected to start in January 2016 at Aroor. Currently the company is earning rental income from its cold storage unit

For FY 2014-15 the company reported profit after tax (PAT) of Rs.0.13 crore on operating income of Rs. 1.11 crore
