Rating Rationale

Acuite has reviewed the long-term rating and short term rating of '**ACUITE D**' (read as **ACUITE D**) to the Rs.13.35 crore bank facilities of BATHSHA MARINE EXPORTS PRIVATE LIMITED. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:
