## **Rating Rationale**

Acuité has reaffirmed the long term rating of 'ACUITE B+' (read as ACUITE B plus) and short term rating of 'ACUITE A4' (read as ACUITE A four) ) on the Rs. 45.00 crore bank facilities of Shanker International Private Limited (SIPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

## **About the Company**

The Haryana-based, Shanker International Private Limited (Erstwhile Shanker Timber Store) was established in 1980 as a partnership firm and converted to private limited in 2013. Led by Mr. Ved Prakash Goyal and Mr. Krishan Kumar Goyal, SIPL is engaged in the trading of timber procured from Singapore, New Zealand and Malaysia.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
