## Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 45.00 crore bank facilities of Shanker International Private Limited (SIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

The Haryana-based, Shanker International Private Limited (Erstwhile Shanker Timber Store) was established in 1980 as a partnership firm and converted to private limited in 2013. Led by Mr. Ved Prakash Goyal and Mr. Krishan Kumar Goyal, SIPL is engaged in the trading of timber procured from Singapore, New Zealand and Malaysia.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
