Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D'(read as ACUITE D)** on the Rs. 22.00 crore bank facilities of B.Y. Agro and Infra Limited (BYAI). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Maharashtra based - Incorporated in 2010, B.Y. Agro and Infra Private Limited (BYAI) is engaged in the manufacturing of copper coils and tubes. BYAI was promoted by Mr. Hasan Shafique.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain.
