Rating Rationale

Acuité has reviewed a long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs.12.00 crore bank facilities of Centex Fabrics Export Unit (CFEU). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in the line with prevailing SEBI regulations and Acuite's Policies
