Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 5.50 crore bank facilities of Henan Fibres (India) Private Limited (HFIPL). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

About the Company

Incorporated in 2002, Henan Fibres (India) Private Limited is a Mumbai-based company engaged in making cotton-blend yarns and polyester yarns, run by Mr. Manish Khimawat and family.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
