Acuité has reviewed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 15.00 crore bank facilities of SONACHI INDUSTRIES LIMITED. This rating is now an indicative rating and is based on best available information.

Incorporated in 2006, Sonachi Industries Limited (SIL), a Maharashtra-based company was promoted by J. B. Tiwari and family. The company is engaged in the manufacture of agro chemicals such as insecticides, pesticides and fungicides at Dadra and has around 140 products.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
