Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.14.75 Crore bank facilities of Zuha Leather Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Zuha Leather Private Limited a Chennai based company promoted by Mr. Shabbeer Ahmed was established in 1986 as a partnership firm and converted to private limited in 2004. The company is engaged in manufacturing of finished leather used to make shoes bags and garments. The company's tanneries are located in Vaniyambadi Tamil Nadu. The directors of the company are Mr. Pudupet Rahmathullah Samiullah, Mr. Moolakadai Mohamed Zaheer, Mr. Pookutti Shabbeer Ahmed, Mr. Moolakadai Mohamed Furquan Sameed and Mr. Pudupet Jawaad Fouzan.
