The Surat-based Sri Mahavir Crimpers (SMC), established in 1987 as a proprietorship firm is engaged in the manufacturing of polyester texturised yarn. The firm is promoted by Mr. Kailashchand Mundra and Mr. Mahavir Prasad Mundhra.
