### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE single B plus**) on the Rs. 9.50 crore bank facilities of Sri Mahavir Crimpers (SMC). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

### About the Company

The Surat-based Sri Mahavir Crimpers (SMC), established in 1987, as a proprietorship firm is engaged in the manufacturing of polyester texturised yarn. The firm is promoted by Mr. Kailashchand Mundra and Mr. Mahavir Prasad Mundhra.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit ratings is based.
