### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 10.00 Cr. bank facilities of Bhansali Jewellery House on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

Established in 2003, Bhansali Jewellery House (BJH) is a Nagpur-based partnership firm promoted by Mr. Jayant Bhansali. BJH is engaged in the wholesale trading of silver, diamond and gold jewellery. The overall operations are managed by Mr. Jayant Bhansali and Mr. Pankaj Bhansali (son of Mr. Jayant Bhansali).

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
