Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus)on the Rs. 6.00 crore bank facilities of Shree Nathji Industries (SNI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shree Nathji Industries (SNI), incorporated in 1995, is a Gujarat-based firm promoted by Mr. Mukesh Kumar Rachh. The firm undertakes cotton ginning, oil extraction and trading of agricultural commodities.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
