Rating Rationale

Acuite has reaffirmed the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 5.20 crore bank facilities of Banerjee Auto Corporation. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Banerjee Auto Corporation (BAC) established in 1999 is a West Bengal-based proprietorship concern promoted by Mr. Partha Priya Banerjee. The firm is an authorised dealer of Bajaj Auto Limited (BAC) for two wheelers in West Bengal. It has three showrooms with 3S (Sales Service and Spares) facility.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
