Acuité has reviewed the long-term rating of '**ACUITE B** (read as ACUITE double B) on the Rs.12.00 crore bank facilities of Leena Multispecialty Hospital. This rating is now an indicative rating and is based on best available information.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Leena Multispecialty, established in 2015 is a Bangalore-based firm promoted by Dr. Rajashekhar and Dr. Shashikala. The firm runs a 50 bed multispecialty hospital that offers treatments across specialities including orthopaedic, neurosurgery, cardiology among others.

For FY2014-15, LMH registered loss after tax of Rs.(2.06) crore on operating income of Rs.0.87 crore.
