#### Ratina Rationale

Acuité has reviewed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 1145.29 crore bank facilities of Tantia Constructions Limited (TCL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

The Kolkata-based TCL, incorporated in December 1964, is the flagship company of the group. The company is engaged in the construction of roads, railways, bridges, among others. Promoted by the Late Mr. G P Tantia as a private limited company, it was converted to a public limited company in 1982. The day-to-day operations are managed by Mr. I.P. Tantia since 1969.

# Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
