Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.15.00 Crore bank facilities of Anita Exports. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Anita Exports (AE) was incorporated in the year 1992 by Mr. OM Prakash Agarwal and family. It is a Kolkata based company engaged in exports of tea. It exports tea to the countries including Pakistan, Dubai, Russia, Malaysia, and Afghanistan. It has its administrative office located in Kolkata.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
