Rating Rationale

Acuite has reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A Four**) on the Rs. 5.00 crore bank facilities of Sana International. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Established in 2011, Sana International (SI) is proprietorship concern promoted by Mr. K. L. Raghavan of Tamil Nadu. SI is engaged in the manufacturing of leather shoes, flip flops (slippers) and sandals. SI has an annual installed capacity to manufacturer more than 10 million units of footwear per annum from its two manufacturing unit based out of Chennai and Panipet of Tamil Nadu.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
