## **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) on the Rs. 15.37 crore bank facilities of Kurseong Carriers Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

#### **About the Company**

Kurseong Carriers Private Limited (KCPL) established in 1972, is a Kolkata based company engaged in providing transportation and complete logistic services all over India. It is also engaged in trading of commodities like tea, salt, rice and supplying to tea gardens in Assam. It has its administrative office is at Kolkata. The overall operation is managed by Director Mr. Sandeep Agarwal. For FY2014-15, KCPL reported profit after tax (PAT) of Rs. (0.48) crore on total operating income of Rs.19.32, as compared with (PAT) of Rs. 0.96 crore on total operating income of Rs.291.87 crore in FY2013-14

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

## Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuité has endeavoured to gather information about the entity / industry from the public domain.
