Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) n the Rs. 15.37 crore bank facilities of Kurseong Carriers Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:
