Acuité has reaffirmed the long-term rating of 'ACUITE C' (read as ACUITE Ca)nd the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 44.00 crore bank facilities of Greatweld Engineering Private Limited (GEPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Greatweld Engineering Private Limited (GEPL) was established in 2006, under the directorship of Mr. Rakesh Rajan, Mr. Suhas Baddi, Mr. Ravindra Mule and Mr. Sateesh Rane in Pune. The company currently manufactures Mild Steel (MS) gratings and hand rails used in engineering, refineries, cement and other industries related to infrastructure. Going forward, it plans to manufacture valves.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
