#### **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and short-term rating of 'ACUITE D' (read as ACUITE Do) n the Rs. 9.04 crore bank facilities of Shree Mahavir Roll Tech Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Incorporated in 2010, the Surat-based Shree Mahavir Roll Tech Limited (SMRTL) was promoted by Mr. Vipul Shah and Mr. Pradeep Kumar Biravat. The company manufactures steel castings in its foundry at Surat (Gujarat). The installed capacity is 300 MT per month.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
